

Jet Ski Damage Protection Add-On Agreement

Port Austin Watersport Rentals INC.

This optional Damage Protection Add-On provides limited financial protection to the renter in the event of accidental damage to the rented jet ski during the rental period. This add-on reduces the renter's financial responsibility for qualifying damage but does not eliminate it.

1. Coverage Limit

The Damage Protection Add-On covers up to \$1,000 in accidental damage to the rented jet ski.

Any damage exceeding \$1,000 remains the full responsibility of the renter.

2. What Is Covered

This add-on applies only to accidental damage to the jet ski itself, including:

- **Hull damage**
- **Cosmetic damage**
- **Mechanical damage caused by accidental impact or operator error**
- **Damage caused by an approved driver listed on the rental agreement**

Coverage applies only during the active rental period.

3. What Is Not Covered

This add-on does not cover:

- **Intentional damage**
- **Damage caused by reckless or negligent operation, including:**
 - **Operating under the influence of alcohol or drugs**
 - **Ignoring no-wake zones**
 - **Operating in restricted or shallow areas**
 - **Beaching the jet ski**
- **Damage caused by an unapproved or unlisted driver**
- **Towing or recovery fees**
- **Loss of keys, safety lanyards, or personal items**

- **Damage occurring outside approved riding areas**
 - **Any damage occurring after the rental period ends**

4. Conditions That Void Coverage

Coverage is void if any of the following occur:

- **Jet ski is used for towing any person or object**
 - **Renter fails to follow staff instructions or posted safety guidelines**
 - **Jet ski is operated by anyone not listed as an approved driver**
 - **Renter engages in unsafe, negligent, or prohibited behavior**

5. Driver Eligibility

Only the renter and any additional drivers approved and documented by Port Austin Watersports are eligible for coverage under this add-on.

Any damage caused by an unapproved driver is fully the renter's responsibility.

6. Pre- and Post-Rental Inspection

A Port Austin Watersports representative and the renter will complete:

- **Pre-Rental Inspection: Documentation of any existing damage**
- **Post-Rental Inspection: Identification of any new damage**

The renter acknowledges that any new damage found during the post-rental inspection is their responsibility.

7. Damage Assessment Authority

Port Austin Watersports retains full authority to:

- **Determine the extent of damage**
- **Select the repair shop or technician**
- **Use standard labor rates and parts costs to calculate repair totals**

The renter agrees to accept the business's assessment and repair determination.

8. Payment Authorization

By signing this agreement, the renter authorizes Port Austin Watersports to:

- **Charge the card on file for repair costs up to the \$1,000 coverage limit**
 - **Bill the renter separately for:**
 - **Any repair costs exceeding \$1,000**
 - **Any damage not covered under this add-on**
 - **Any towing, retrieval, or loss-related fees**

9. Cost of Add-On

- **Add-On Fee: \$20 per rental period**
 - **Fee is non-refundable once the rental begins**
